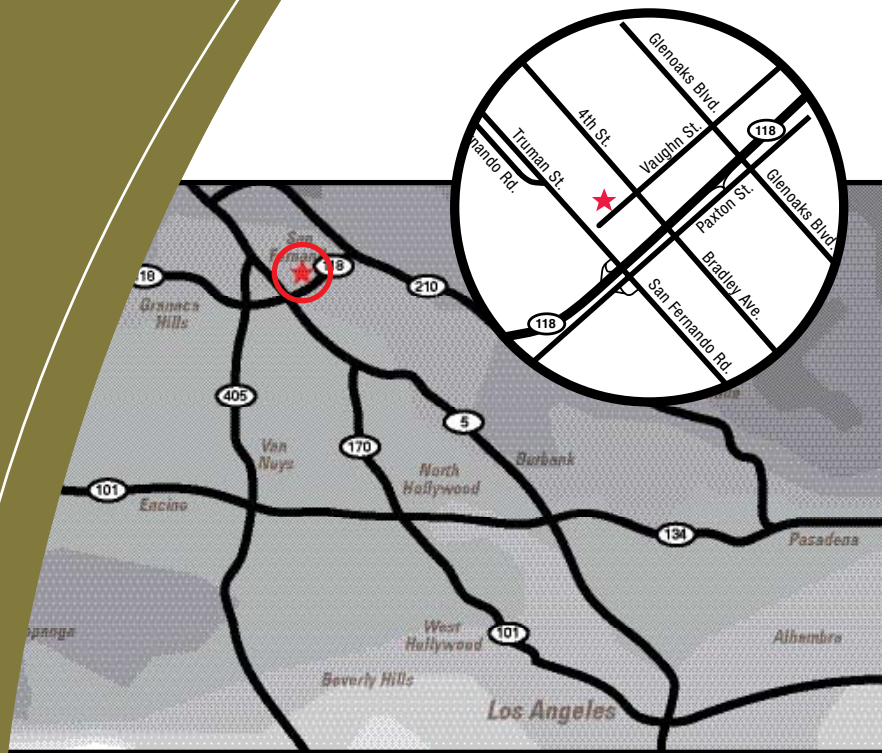

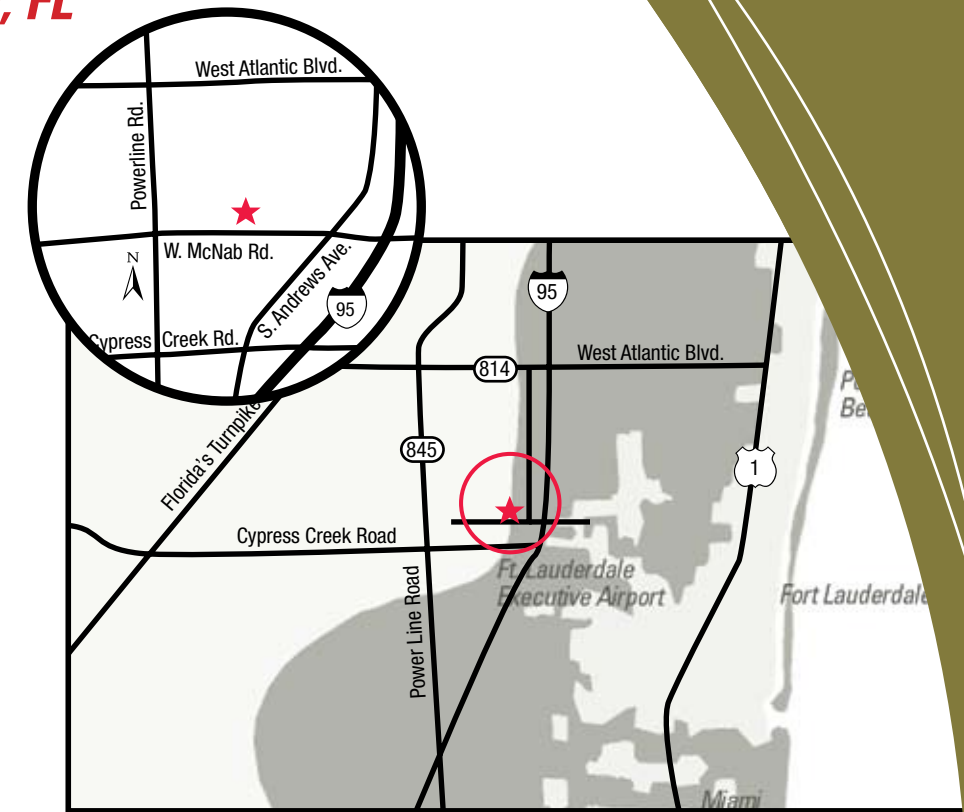

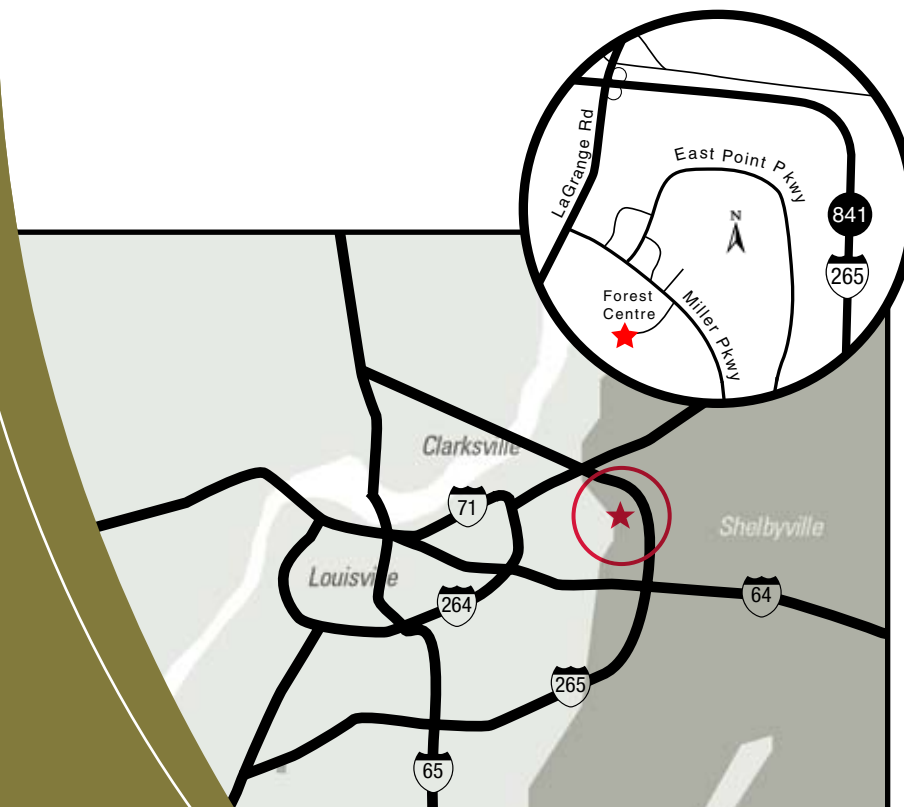

From Kentucky Trailer Services to New Haven Moving Equipment: Start out turning left onto Farmington Ave and go to Crittenden Drive. Make a left turn onto Crittenden Drive at stop sign. Merge onto I-65 North toward Downtown Louisville. Merge onto I-71 North via Exit #137 toward Cincinnati. Merge onto I-265 South/Gene Snyder Expressway via Exit #9A. Take KY-146/LaGrange Rd. Exit #30 toward Anchorage. Turn Left onto LaGrange Rd./KY-146 West. Go to the entrance of Eastpoint Business Center. Make a left turn onto Nelson Miller Parkway (first left turn from LaGrange Rd.) Make a right turn onto Forest Centre Court to the ABC Distribution Centre. Forest Centre Court winds to the left. New Haven Moving Equipment is the first building on the right.
